<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p>Tier 1 <a href="#">Network providers</a>:  <b>\$1,700</b>/individual or <b>\$3,400</b>/family                      Tier 2 <a href="#">Network providers</a>:  <b>\$3,400</b>/individual or <b>\$6,800</b>/family  <a href="#">Out-of-network provider</a>:  <b>\$8,000</b>/individual or <b>\$16,000</b>/family</p>	<p>Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. The <a href="#">deductible</a> is <b>Embedded</b>. If you have other family members on the <a href="#">plan</a>, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a>.  <b>Deductible year runs 01/01 – 12/31</b></p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. <a href="#">Preventive care</a> services are covered before you meet your <a href="#">deductible</a>.</p>	<p>This plan covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this plan covers certain <a href="#">preventive care</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a>. #### **Does this plan provide Minimum Essential Coverage? Yes**
